Havells India Q4 Net Profit up by 35%; Revenues grew by 9%

New Delhi, May 11, 2016: Havells India Limited, a leading Fast Moving Electrical Goods (FMEG) Company, today announced its financial results for the fourth quarter and the financial year ended March 31, 2016.

Q4FY16 vs. Q4FY15 (Standalone basis)

- Net Revenue for Q4FY16 grew by 9% to Rs. 1,475 crore as compared to Rs. 1,349 crore in Q4FY15
- **EBIDTA** for Q4FY16 grew by 22% to Rs. 220 crore as against Rs. 180 crore in the corresponding quarter previous year
- Net profit (PAT) before exceptional item grew by 35% to Rs. 164 crore as compared to Rs. 122 crore in Q4FY15

Commenting on the financial performance Mr. Anil Rai Gupta, Chairman and Managing Director (CMD), Havells India Limited, said, "The performance in Q4 underlines an encouraging trend of positive revenue and profitability growth. We have implemented several structural decisions which should support growth going forward as well".

Standalone basis FY16 vs. FY15

- **Net Revenue** for the year ended March 2016 grew by 4% to Rs. 5,437 crore compared to Rs. 5,239 crore in the corresponding period of the previous financial year
- **Earnings before Interest, Depreciation and Taxation (EBIDTA)** grew by 7% to Rs. 749 crore as against Rs. 699 crore in the corresponding period of the previous financial year 2015
- Net Profit (PAT) for FY16 before exceptional item grew by 10% to Rs. 513 crore as compared to Rs. 465 crore in the corresponding quarter of previous financial year. The exceptional item of Rs. 202 crore is the result of profit on 80% stake sale in Sylvania.
- Value growth was impacted by the drop in commodity prices, thereby offsetting higher volume growth.

Business Segments (FY16 vs. FY15)

- Electrical Consumer Durables grew by 11% to Rs. 1,141 crore in FY16 as compared to Rs. 1,028 crore in FY15.
- The lighting and fixtures business grew by 8% to Rs. 802 crore in FY16 as against Rs. 741 crore in FY15. Within this, LED lighting grew by 100% and this comprises 51% of lighting division's total revenues.
- The revenue growth for both switchgear and cable divisions remained flat year on year. However, in volume terms, industrial cable grew by 14% and domestic cable grew by 11% but this did not translate into revenue growth due to downturn in commodity prices LS INDIA LTD.
